Motion by Christian, second by Hose, to adopt Resolution 2019-5-7c, Be it resolved, that the Township Board is ecord in support to legislation that would allow township boards the option to have its elected offices appear as nonpartisan on the ballot. The discussion for the officials positions are as follows: Trustee Christian expressed his support of nonpartisan offices. He stated that voters should take the time to educate themselves regarding the person running and not rely upon the party with which the person is affiliated. He further stated his hope that straight party voting be eliminated and voters use careful consideration of each office. Trustee DuPuis declined to comment. Treasurer Hose supported Trustee Christian's opinion. Clerk Milburn expressed her agreement with Trustee Christian in that voters should carefully consider their vote but reminded the board that straight party voting had been part of Proposal 3 on the last ballot and was passed by voters therefore it is voters Constitutional right to vote straight party. She further stated that having a party affiliation gives the voter an idea what guidelines an elected official may use when considering their vote on township issues. Supervisor Randall expressed her hesitation with a township board deciding whether its members should be partisan or nonpartisan. She further stated her hesitation regarding what could possibly be in the bill as far as would all offices be included or could offices be chosen individually.
