- Township offices and Community Hall will be through April 6, 2020, and Compost/Recycle Center until further notice, with regular monthly meeting to still be held, possibly by video conferencing.

Board discussed items that needed attention during closure as follows;

- Treasurer will verify with carpet installers if installations will still be scheduled and if so will coordinate removal of furniture and installation.
- Trustee DuPuis will verify current Maintenance Lead availability.
- Trustee Christian will contact Fire Chief Williams to update.
- Supervisor will coordinate with IT Right installation of server and new computers, if still scheduled.
- Consensus of Board to allow Supervisor to contact Top Notch Electric regarding electric meter at Lakeview Park that was destroyed by drunk driver to make sure it is secure and to repair and Clerk to contact insurance company for coverage.
- Motion by Randall, second by Christian, to authorize Clerk to pay all recurring and authorized bills and payroll through April 6, 2020.
- Treasurer will check on what is needed to allow all departments to use option for pay through website and Deputy Clerk will contact new website creator to see what is need to get up and running.
- Clerk will get 2020 Compost Center Permit stickers order finalized.

There was further discussion regarding park maintenance. Motion by Randall, second by Christian, to offer position to Lou Tomma as part-time Maintenance Lead effective immediately at the rate of \$15.00. All ayes, Motion carried.
